Approve January Minutes: Mary made a motion to approve the January minutes, Max

seconded the motion.

Treasurer's Report: (Refer to February 2020 Treasurer's Report)

- January ending balance was \$6944.35 in the small business account and \$10,000 in the reserve account
- The reserve account is up and running
- 2019 dues are all accounted for from the membership
- Title company collected the first set of dues from "Hangar and Mash"

Old Business: Brief Review of the issues before the board – this will be very brief as most of the meeting will be addressing the Annual Meeting in March

- Bike/Walking Path: Craig's excavator broke, delaying any progress on his part on the trail
- Bump Revisions:
 - Craig reports the provider of the bump modifications is still scheduled to do the work soon.
 The bumps will be turning into humps some are being relocated along with the asphalt ending point will be evened up.
- Road Maintenance:
 - The work on the north section of Crawford that we have paid for will continue as weather permits and Mitch recovers from the flu
 - O The culvert just north of Carly and Auston talked with road contractors about enlarging the "pond" but can't do that work until summer because of mud issues. All road contractors and engineers unanimously agree the culvert will save this section of the road and can be better managed from the forest side. We visited an example of an amendment Mitch used on the new driveway off Crawford very effective and we will be using this on the northern section and most likely on this section as well. But also continue to believe that this will be an effective feature of our future trail and will pursue the "pond" feature when weather permits and have included this in budgeting process with Mitch. We understand that a driveway is planned for this area and will need to adjust as necessary when the driveway is located. John Lloyd with QuickSilver Construction, LLC will be given the opportunity to plan/help create/quote the pond project.
 - Max will address 2020 work as it relates to next year's budget in the budget portion of the
 Annual Meeting discussion and all property owners will be notified of the work proposed. Some
 will require written notice as that is the only contact info we have.

- Creation of Reserve Account max we have a preliminary budget for this account.
- Discussion regarding working with the county to get participation in annual road maintenance Talked to Helen. Working with county engineers who have suggested a letter to the Commissioners budgeting process is starting soon so good timing. Max is putting together a letter. Then we will need to follow up with meetings with the individual commissioners. I think we have all been very clear that the community will be highly resistant to paying for a new road without addressing the old road. Most recent news from Helen is that it is difficult for public entities to contribute to private entities. Still talking with Bill Oakes to find a loophole

New Business:

- Another board meeting scheduled for March 9, 2020 has been arranged specifically to talk about assessments and bylaws.
 - Proposed new assessments based on budget
 - Approval of plain language bylaws by the board. Need to ensure the wording in the bylaws allows for the bylaws to be revised without the need to file them every time with the county.
- Discussion regarding a contingency plan in the event all gatherings need to be cancelled due to the coronavirus. Possible virtual meeting???
- **VOTE:** Tara made a motion to approve the following definition and it was seconded by Mary— motion approved.

Property will be considered "developed" upon creation of vehicle access or installation of utilities, whichever comes first.

- Clarification that the Bylaws do allow for MCRA to take out a loan
- Do you think we should mention the state law that says that even if you aren't a member of the association you are required to pay for maintenance of the road? Or maybe that goes out in the announcement to the non-members as a reason to join the association so they can have some impact on the way the road is managed? Agreed this should be done tastefully.
- Max and Mary shared a proposed budget that introduces the opportunity to chip seal Crawford road and how assessments will be impacted.
